TERMS & CONDITIONS

1. Interpretation

- a. "The Company" refers to The Mobile Hairstylist.
- b. The "Buyer" means the person, who has placed the order subject to these terms and conditions.
- c. The "Services" means the services to be provided as described in the attached letter.
- d. The "Wedding" means the date upon which the buyer has contracted for provision of the services.

2. Contract

- a. The Buyer wishes that the Company provide the services to the value quoted in the attached letter.
- b. The contract is made only upon the Company's acceptance of the Buyer's order for the services which are the subject of the contract ("The Services"). The date of the contract will be the date the order is accepted by the Company. The date the services are to be provided is detailed in the covering letter

3. Price

- a. All prices, quotations or other materials issued by the Company are for guidance only. The Company does not warrant that the information supplied is up to date, error free or accurate and any errors will only be honoured at the Company's discretion.

4. Payment

- a. Payment of a booking deposit of £70 is required at the time of booking and constitutes acceptance of the Terms and Conditions. This deposit is non-refundable. The balance of payment must be made no less than 30 calendar days prior to the wedding.

5. Delivery

- a. Delivery of the services shall be the responsibility of the Company.
- b. The Buyer shall be entitled to cancel the contract at any time. A refund minus the booking deposit shall be made only when the contract is cancelled no less than 30 calendar days prior to the wedding. The buyer may choose a credit note, taking into account the original method of payment at the company's discretion. Written confirmation is required within 24 hours of the notice of cancellation for the cancellation to be effective.
- c. No refund will be made for any unused part of the contracted service period.

6. Receipts

- a. A receipt will be issued upon payment of deposit and balance.

7. Photography

- a. Under the 1988 copyright act, I understand the images taken at the trial/wedding day are the copyright of the company. I will allow the company to use the images in displays, exhibitions, presentations, editorial and advertising at any time in the future without the company having to seek permission. I understand this is a model release.

8. Liability

- a. No liability rests with the company regarding any personal injury, financial loss, consequential or indirect loss.
- b. If no notice is received by the Company upon completion of the services the services shall be deemed to have been accepted by the Buyer as acceptable and in line with any description in the contract. No claims will be accepted thereafter. If it should be agreed by the Company in relation to any claim that the Buyer was entitled to reject the services then any damages recovered by the Buyer shall be limited to the purchase price under the contract. The company will not be liable if the buyer and/or service recipients are not available at the stated time for delivery of the services.

9. Complaints and Disputes

- a. The Company follows the Freelance Hair and Beauty Federation Association Code of Practice and will honour all guidelines set out in this Code of Practice.

10. Force Majeure

- a. Any liability of the Company shall be excluded in the event of any circumstances beyond its control preventing it from carrying out its obligations.

11. Law

- a. The contract does not affect the consumer's statutory rights.
- b. The contract shall be governed in all respects by the laws of England and jurisdiction of the English court
